



## **VISITOR POLICY**

### **The Meadows**

Effective Date 2 April, 1984  
(reviewed 17 June, 2010)

### **POLICY**

Persons not having a valid PHRC license may be granted access to the restricted and regulated area of the Stable Area by following the guidelines of the Meadows Visitor Policy. The admission of visitors to the Stable Area is a privilege granted by Meadows management and the guidelines and procedures are solely controlled by Meadows management and the Meadows Security Department. No part of this policy is meant to circumvent or contradict any regulation of the PHRC.

### **SCOPE**

All corporate and company employees, owners, trainers, drivers, employees of owners and trainers, MSOA personnel, vendors, PHRC employees, XpressBet employees, private delivery employees, contractors, and all persons in the Stable Area.

### **GUIDELINES**

1. Any person without a valid PHRC license is to fall under this policy. A "valid" PHRC license is one that is current and fully-recognized by the PHRC.
2. Any person with a valid PHRC license but without a functioning business in the Stable Area (such as a non-roster groom, a non-stabled horseman, a horseman under suspension, etc) may be identified by Security as a visitor.
3. Visitors may be signed in by a licensed owner, driver, trainer, management personnel, MSOA personnel, or PHRC personnel. Grooms may not sign in a visitor.
4. Visitors will be photographed by Security at the Stable Gate using the Stable Identification System. Visitors will also be logged in on the Visitor Log.
5. Visitors must present a form of identification to Security, such as a driver's license.
6. The person who signs in the visitor must come to the Stable Gate, sign in the visitor, and physically escort the visitor while he is in the Stable Area.
7. The person who signs in the visitor accepts full responsibility for the visitor's actions and behavior.

8. Security has discretionary power concerning a request to sign in a visitor. If a person's behavior, actions, background, or history are deemed unsatisfactory by the Security Officer, the person may be denied visitor privileges.
9. Security will establish times that visitors may be signed in and times that visitors must leave the grounds.
10. News or media personnel are never permitted to enter the Stable Area unless specific permission is granted by Management and, unless otherwise stated by Management, must be accompanied by a Management person. During special events, such as Adios Day, Press Passes may be issued by Management.
11. Administrative or management personnel who are expecting visitors will notify the Stable Gate in advance of a scheduled appointment.
12. General visitation privileges can be granted to contractors performing work in the Stable Area.
13. Special Event situations (such as Adios Day, special celebrations, church services, etc.) will be handled through the Director of Security with the cooperation of the PHRC.
14. Visitors or persons signing in visitors may lose visitor privileges if they disregard policies or violate the guidelines of the Visitor Policy.
15. Only official business or occasional visits by friends is authorized.
16. Attempts to use the visitor policy to circumvent a person getting a PHRC license (such as working in the stable area) will not be tolerated.
17. The husband, wife, or minor child of a trainer, owner, or driver without a PHRC license does not need to be signed in under the Visitor Policy providing that person does not perform work in the stable area.
18. No private vendors, veterinarians, or sales persons may enter under this program.
