Who is eligible? Owners, trainers and drivers of Standardbred race horses are eligible for membership if they are licensed as such in Pennsylvania, are a member in good standing with the United States Trotting Association, and are the owner, trainer, or driver of any horse entered in a harness racing event at The Meadows during the current or preceding racing season.

What's it cost? Dues are **\$25.00 per individual** calendar year regardless of date joined.
Dues must be paid with application.
