**Who is eligible?** Trainers and drivers of Standardbred race horses are eligible for membership if they are licensed as such in Pennsylvania, are a member in good standing with the United States Trotting Association, and are the trainer or driver of any horse entered in a harness racing event at The Meadows during the current or preceding racing season.

**What's it cost?** Dues are **\$25.00** per individual or **\$35.00** for a husband and wife together **when individually eligible for membership**, per calendar year regardless of date joined. We further recommend that individual members contribute \$5 of every starter fee they are awarded this year to the MSOA Political Action Committee, which is used to protect our profession from any potentially harmful changes in Harrisburg.

Renew your membership no later than **January 31, 2015** to have continuous coverage of the Third Party Liability, Sulky and Fire & Disaster Insurances offered to you free with your membership in the MSOA.
